If the total amount is not paid by the last day of the following month the account is past due and a service charge will be applied, calculated on the last day of each month on the balance as of the last day of the previous month, (less payments and credits to said balance,) until payment in full is made. Service charges on past due accounts will not exceed 1.5% monthly with an annual percentage rate of not more than 18%. If this account becomes delinquent it is hereby agreed that Applicant will pay for all collection agency fees and/or legal fees that are paid by Creditor to collect this account.

In consideration of credit being extended by Few Ready Mix to the named applicant for merchandise to be purchased, whether applicant be an individual or individuals, a proprietorship, a partnership, a corporation or other entity, the guarantor or guarantors each hereby contract and guarantee to Few Ready Mix the faithful payment, when due, of all accounts of said applicant for purchases made upon activation of this account. The guarantor or guarantors each hereby expressly waive all notice of acceptance of this guaranty notice of extension of credit to applicant, presentment, and demand for payment on applicant, protest and notice to guarantor or guarantors of dishonor or default by applicant or with respect to any security held by Few Ready Mix, extension of time of payment to applicant, acceptance of partial payment or partial compromise, all other notices to which the guarantor or guarantors might otherwise be entitled and demand for payment under this guaranty. Any revocation of the guaranty shall be in writing and delivered to Few Ready Mix Concrete Co. at PO Box 1870, Jasper, TX 75951.
